

ADMISSION TO B.Sc. NURSING COURSE on N.R.I. CATEGORY SEATS

Academic Year 2023-24 - Prospectus & Instructions to the Applicants (Christian, Girls only)

- 1. Applications for admission to first year B.Sc. Nursing (Academic year 2023-24) in the **4** NRI category seats at this college is being invited on the basis of this prospectus.
- 2. **Academic Eligibility:** To be eligible to apply for the B.Sc. Nursing course, the applicant must have completed and passed the 10 + 2 examination with cut-off limit of 50 % of marks set for NRI category is 78% marks under the Kerala State Higher Secondary Board (Kerala HSC) OR Central Board of Secondary Education (CBSE) OR Indian School Certificate Examination (ICSE) after a period of 12 years study, the last two years of study comprising of Physics, Chemistry and Biology with English at a level not less than the core course for English as prescribed by the National Council for Educational Research and Training (NCERT).

Note: All applicants must have taken courses in **Biology**, **Physics and Chemistry** in addition to English in the High School Years (during their 10th, 11th and 12th). They should have secured 78 % marks in **Biology**, **Physics and Chemistry** at the Plus Two level.

Only students from high schools accredited by the respective State or the country and as such approved by the Association of Indian Universities and Kerala University of Health Sciences will be eligible for admission and **Equivalency Certificate** to this effect shall be produced.

3. **Age Requirements:** Applicants must be at least 17 years of age on 31st December 2023 (the date of birth being shown on the Matriculation or equivalent certificate).

- 4. Eligibility for admission to N.R.I. Category Seats: According to the GO (MS) No.243/2014/H&FWD dated 06.08.2014, "An Applicant who depends upon his/her Father / Mother / Brothers and Sisters (inclusive of first cousins) / Husband / Wife / Brothers and Sisters (inclusive of first cousins) of Father or Mother / Half Brother / Half Sister / Adopted Father or Adopted Mother who is working abroad" will only be eligible to apply in the NRI category seats.
- 5. Copy of the following documents duly attested by a Gazetted Officer to prove the NRI status shall be submitted along the with the certificates and print out of the application.
 - Copy of the Overseas Employment Certificate issued by the employer, attested by the Embassy OR if self-employed, a statement in this regard that is duly attested by the Embassy.
 - ii. Copy of the relevant pages of the passport containing visa details that is attested by the Embassy.
 - iii. The NRI relative who is sponsoring the candidate should be an Indian Citizen/Overseas citizen of India/Person of Indian Origin and relevant document to prove the same.
 - iv. A self-affidavit/declaration (*find specimen format Annexure-1*) by the NRI relative (Sponsorship Certificate). The Candidate shall produce the sworn affidavit from the Sponsor in a stamp paper worth Rs. 200/-. The same shall also be notarized by the Notary Public, disclosing that the student is dependent of the sponsor and the all expenses i.e. tuition fee and special fee, of the candidate for the entire course period will be borne by the Sponsor.
 - v. Relationship Certificate to be issued by the Revenue Authorities to prove the relationship between the candidate & the NRI relative as per GO (MS) No.243/2014/H&FWD dated 06.08.2014.
- 6. **FEE STRUCTURE:** A selected applicants in NRI category is liable to pay the following fees:

- e) Scanned copy of recent (taken latest in 2023) passport size color photograph. Photograph should be taken in a white/light color background. The image should be in **JPEG** format maximum size for photograph **50kb** and image dimension is **120x150 pixels**.
- f) Scanned copy of Student and guardian Signature
- g) Fill up the Self declaration form Annexure 1
- h) Scanned copy of the Certificate. The image should be in JPEG/PDF format. Maximum size for JPEG/PDF files 500KB

 - Aadhar
 - NRI related all documents (**Ref No.6**)

The college cannot be held responsible for non-receipt or late receipt of applications, under any circumstances. The application form should be completed carefully; furnishing the entire information called for. Late and incomplete applications and applications not in the prescribed format will be summarily rejected.

- 7. While reporting for admission the entire relevant certificates/documents original as listed below should be submitted to the institution.
 - ➤ The relevant pages of SSLC book/equivalent board certificate as proof of the age and date of birth.
 - Certificate and the mark list of SSLC, Plus Two,

- ➤ Anti Ragging Certificate from the institution last attended (preferably issued within six months).
- ➤ Conduct Certificate from the head of the Institution last studied in proof of the clause (prohibition of Ragging, point 11.) of this Prospectus.
- > Transfer Certificate (T C)
- ➤ Migration Certificate if applicable
- Copy of photo ID proof (Aadhar/ voter ID/ Passport)
- Copy of the format of online application form
- ➤ Every candidate before admission to the course shall submit to the Principal of the Institution a Certificate of Medical Fitness from an authorized Medical Officer with MBBS or higher qualification certifying that the candidate is fit to undergo the course.
- ➤ Date of birth and name printed Photograph Passport size 10 Nos and Stamp size 2 Nos
- Additionally, four sets of photocopies of all the above certificate / documents attested by Gazetted officers have to be submitted at the time of admission.

Conversion of NRI seats to open merits under management quota • Unfilled seats if any under NRI quota will be reverted back to the open merits under management quota.

- 8. As per the regulations of the University and the Regulatory Council, admissions will have to be closed by 31 August of the year of admission. Therefore, those who leave the course after the closure of admissions will have to pay liquidated damages equivalent to the tuition fees for the remaining period of the course. Any complaints in this regard shall be subject to the legal and factual scrutiny and the decision of the ASC/FRC. The colleges shall return the Certificate and TC of these students, on execution of a bond by the student along with any of his/her Parents, undertaking to pay the amount that may be ordered by the ASC/FRC or the Court of Law.
- 9. All students who get selected should get themselves vaccinated against Hepatitis and Covid 19 before admission. A certificate to the effect shall be produced at the time of admission or before commencement of the course.
- 10. Every student is required to adhere strictly to the Code of Conduct of the college.
- 11. **Ragging is strictly prohibited.** If it is found during the admission or any time thereafter that the applicant has indulged in ragging in the past, admission may be refused or the student shall be expelled from the institution. Whoever commits, participate in, abets or propagate ragging within or outside the institution shall be suspended from the institution with immediate effect and the Principal shall report the matter to the civil/police authorities.
- 12. Without prejudice to the directions of the Nursing Councils/Government/University, the decision of Holy Cross College of Nursing, Adoor shall be final on all matters with regard to admission.
